## Introduction

The EA Networks Centre is 100% owned and operated by Council. It features five indoor pools, four indoor courts, two outdoor courts and a fully equipped fitness centre.

The \$35 million EA Networks Centre was opened on 9 May 2015, a council-community project that had been in the making since 2007. The Ashburton Stadium Complex Trust drove fundraising efforts and together with the community, raised \$5 million dollars.

The initial site selection, building design and subsequent land purchases by Council were made with an eye to the future, with the intention of expanding the current centre to create a larger sporting hub.

EA Networks Centre plays an important role in making our district a great place to live. We know that this asset is valued by the community, it contributes to our wellbeing and provides significant economic benefit for our district when larger events are held.

To get the best outcome for generations to come, we need a plan that ensures development at the site is logical, supported by the community and keeps the centre relevant to our growing and changing district.

## How will the plan be actioned?

This plan proposes where we see the development of EA Networks Centre heading over the next 30 years. It aims to provide an overall vision to help guide future projects in the area.

It is important to note that many of the individual projects identified within this draft plan are not currently funded.

When the need exists and funding is available, the identified projects will be included in a future Long Term Plan or Annual Plan, and community consultation will occur as part of this process.



#### The Play, Active Recreation and Sport Strategy adopted in 2022 identified the need to complete a stocktake of sporting groups' current and future needs.

In 2023, we completed a utilisation study of sports facilities and Council land across the district. The study showed that some areas of the EA Networks Centre are already being used at capacity during peak times, and that the growth of some sports will be limited due to the size of current facilities. This shows there is a need for more space for both current and future generations.

While the Masterplan aims to increase capacity for areas struggling to meet current and projected demand (such as the indoor court space), we also wanted to add more active recreation and play activities within the plan to join the existing disc golf course and outdoor court space (such as a mini golf course, a hydroslide and allocated space for play within the stadium). The purpose of the Masterplan is to show the community what can be achieved on the land we currently own. If implemented, it will ensure staged development of the proposed projects, resulting in a future-proofed, cohesive and well utilised community asset. The plan will also prevent adhoc, unplanned development and help us to maximise the space available.

- Currently, EA Networks Centre has 318 car parks, consisting of 188 permanent spaces with an additional 130 spaces in the overflow area. Under this plan, two new car parking areas would increase total capacity to 591.

#### **Oak Grove steps**

We have also recently installed steps that connect the Oak Grove footpath to the EA Networks Centre.

#### 2023/24 | \$28,000

#### Outdoor sand court 17

#### → Project starting soon

A minor project scheduled to be completed in the 2023-24 year is an outdoor sand court that the community can use. As this is to be completed before June 2024, it is not included in the draft Long Term Plan 2024-34.

#### 2023/24 | \$30,000

#### Vehicle entrance widening

A project to widen and add an additional lane at the existing vehicle entrance has been included in our proposed Draft Long Term Plan 2024-34.

This would help solve the current challenges when exiting the EA Networks Centre car park onto State Highway 77 at peak times.

2024/25 | \$155,000 (Year 1 of draft Long Term Plan)

#### Solar farm

The draft Masterplan includes a proposed 1 hectare solar farm, which has been designed to produce enough electricity to power the EA Networks Centre and secure the financial energy spend of the facility.

In time, this is expected to increase sustainability and fix a key operating cost for the facility.

The budget indicated below will facilitate early preparatory work, however the construction of the solar farm itself will require further funding in the future.



## Internal building changes

Included in our draft Long Term Plan budget is a project to make some internal changes to the EA Networks Centre building. We are proposing to reconfigure existing office and staff spaces to incorporate a 100m<sup>2</sup> studio that could be used for a number of activities including dancing or yoga.

The project would include moving the staff room to the opposite end of the building. Since this project is already included in proposed budgets, it is not included as part of this Masterplan.

#### Stadium extension

A stadium extension has been included in the draft Masterplan due to the high usage that we are already seeing in the stadium. We have also heard from key stakeholders that capacity here is already an issue and sport growth and participation is being curtailed. A stadium extension also has the positive economic flow-on effect of bringing additional tournaments and events to Ashburton.

This draft Masterplan includes two options for the stadium extension – an extension of two courts or an extension of three courts, and Council's preferred option is the three court extension. This is what has been included as part of the draft Long Term Plan 2024-34.

#### **Aquatic extension**

The 2023 Utilisation Study identified that the indoor pool at EA Networks Centre had high levels of utilisation. At times, the Learn to Swim pool is at capacity and demand is growing for this activity. The indoor pool extension included in this plan would relieve the capacity issues year round, whereas the

The Masterplan allows space for the following activities; an additional indoor pool or an outdoor pool, a hydroslide, wet/ dry climbing wall, wet obstacle course and splash deck designed for older children.

outdoor pool option would only assist in the

summer months when operating.

Council's current proposal involves an outdoor pool with the possibility of an integrated splash area, and this has been included in the draft Long Term Plan 2024-34. This project was preferred over the option to rebuild Tinwald Pool due to ongoing operational efficiencies.

#### **Hockey turfs**

The Masterplan includes two new artificial 5 turfs. The current hockey turf is an area that was identified in the Utilisation Study as having high levels of use. The proposed turfs could service hockey, turf sports and other recreation opportunities. The turfs are proposed to be orientated for optimal daylight conditions.

#### Multi-purpose sports fields

Two multi-purpose sports fields are inclu 8 as part of the proposed vision. It is expected that these fields could be used for a variety of sports such as rugby, league, football and softball. The sports fields are proposed to be orientated for optimal daylight conditions.

#### Mini golf course

The plan includes a mini golf course. It's 16 proposed that the course would not be staffed, and users could either bring their own golf balls and clubs or hire them from reception at the EA Networks Centre, which is the same model as the disc golf course at Smallbone Drive.

This is included in the plan as a lack of low cost/no cost recreational activities has been identified as a gap in the Ashburton District, we expect it would provide enjoyment to the community.

#### **Playground equipment**

Playground equipment has been included as part of the plan to provide an opportunity for spontaneous play and entertainment for younger family members. This reflects what has been set out in the Play, Active Recreation and Sport Strategy 2022.





#### **Outdoor courts**

Under this Masterplan the existing outdoor courts would need be relocated to make way for the stadium extension project. These community courts would remain free for all to use. When tournaments are on, these courts are also used for additional space and warm up areas. These are labelled as in the draft plan.

#### Disc golf

It's expected that two disc golf holes will need to be modified to provide space for the other proposed devlopments.

## Vehicle entrances, parking and drop off areas

An additional vehicle entrance is included as



part of the plan, as well as widening of the current entrance. Additional car parking is also part of the vision, and is proposed to have an extra 403 parking spaces, as well as a bus drop off area and service vehicle access to the sports fields. These projects are seen as necessary to support future development and an increasing number of visitors to the sports hub as a whole.
